2. Ex- Officio Member Reports:

Friends of Fiscalini Ranch Preserve: JoEllen made a report on the state of the test plots. We will pay for the work on the remaining two out of our budget as it is difficult ,because of the fires, to get the Cal Fire crew. We will put it out to bid with private contractors. We have developed a new plot 1, as it was in the wrong place. Test plot originally 1 will become test plot 3 B and will be eventually chipped. We will also see that the trees on that test plot are not limbed up as was done on test plot 3. There has been looting on the Midden. Ways to protect the Midden will be discussed at our next FFRP meeting. September 17 is Coastal Clean up Day.

4. General Manager's Report and Facilities and Resources report were made by Jerry Gruber as Carlos Mendoza was absent :

a. We have a verbal from the County that the permits and applications are ready to go for the project on the East Ranch. Civil Design Studios and Firma can now put it out a bid packet once final written approval is received. Grading and drainage has been narrowed in scope due to the elimination of the area that was identified as the flood plain. b. A report about the Bio Mass Cogeneration Plant was discussed. It is still being discussed with the plant in Berkeley who makes the machinery. The question ,is it something viable for us to use ,is still being studied.

c. There is a Trails Workshop September 15, 2016, The PROS Commission is invited to attend.

d. The Phillips house demolition has been approved. Maybe a bench with a plaque commemorating the original owners would be warranted. We were reminded by JoEllen that the Phillips house is not on the Ranch and is on CCSD Property.

e. The Fiscalini Tank is being rebuilt.

f. The EIR is out and on the Web Site.

g. It appears the reservoir for Brine is no longer needed. This might be used to hold water? Where would the Brine go? It can be trucked off site.
