4. Parks and Recreation Manager's Report: Hoping the Reverse Osmosis Plant will be up and operating by Friday this week. New finance person, Patrick OReilly, on board.\$20,000 short as revenue for waste water is down. However, staff has been reduced. If Pros would like a field trip next meeting to see the new plant it can be arranged. Gail Robinette is the new President and Muriel Cliff Vice President of the CCSD board.

Ranch Manager's Report: There are still 12 trees that are dangerous to homes that need to be removed. Carlos and crew have removed trees that were covering trails on the Ranch after the last storm and fixing washed out trails. There have been three more dog bites on the Ranch. The whole floor at Vet's Hall will be redone.

5. Regular Business

- A. An update from Chief Miller and Dan Taylor from Fire Safe Council of SLO was received. FFRP, Greenspace, CCSD and Forest Committee have worked on the Grant and now it is moving to the next level. This is good news in that it might mean we could receive the grant. The committee must reduce the amount they are asking for to go on to the next round. The amount will need to be reduced to \$500,000.lt needs to be resubmitted by February 27, 2015. There are two grants that are coming in the future from Cal Fire we can apply for. They are being funded by the SRA fees. General Manager Gruber requested that a member of CCSD and Pros sit on the Committee.
