SUMMARY OF ORDINANCE**

**AN ORDINANCE AMENDING SECTION 4.12 OF THE
CAMBRIA COMMUNITY SERVICES DISTRICT MUNICIPAL CODE
RELATING TO THE WATER SHORTAGE CONTINGENCY PLAN**

This Ordinance Summary is published in accordance with the provisions of Government Code Section 25124. On September 16, 2021, the Board of Directors of the Cambria Community Services District introduced Ordinance 03-2021 amending Chapter 4.12 of the Cambria Community Services District Municipal Code relating to the Water Shortage Contingency Plan.

At its June 17, 2021 regular meeting, the Board of Directors adopted the 2020 Water Shortage Contingency Plan (WSCP). The WSCP is based upon the District's adopted 2020 Urban Water Management Plan, and the requirements of California Water Code Section 10632(a)(3)(A). Section 10632(a)(3)(A) provides for the inclusion of six standard water shortage levels corresponding to progressive ranges of up to 10, 20, 30, 40, and 50 percent shortages, and greater than 50 percent shortage in water shortage contingency plans. Ordinance 03-2021 implements the WSCP and replaces the prior Emergency Water Conservation Program in its entirety.

Per California Water Code Section 10632, all urban water suppliers are required to include written procedures to conduct an Annual Water Supply & Demand Assessment as part of their WSCP. Ordinance 03-2021 also adopts Appendix 4.12A, which includes the required procedures for the annual assessment.

The Board of Directors must vote again to adopt the Ordinance. That action is scheduled for Thursday, October 14, 2021, at a regular meeting to begin at 2:00 p.m. Pursuant to Government Code Section 54933(e) and AB 361, members of the Board of Directors and staff will participate in this meeting via a teleconference.
