RECOMMENDATIONS:

Staff recommends the Board of Directors discuss and consider scheduling a new date for a special meeting to update the goals and objectives of the CCSD Strategic Plan as part of the sixmonth update.

FISCAL IMPACT:

Fiscal impacts associated with this item include staff time, Snider and Associates consultant services and AGP Video costs. The cost of AGP for a Zoom meeting is \$350 (maximum of 3 hours) and \$125 for each additional hour and the consultant services costs are \$4,800 (included in the approved FY 2020/2021 Budget).

DISCUSSION:

RECOMMENDATIONS:

Staff recommends the Board of Directors discuss and consider the opportunity to propose projects for Community Project Funding through the office of Congressman Salud Carbajal and direct staff to submit project proposals for funding consideration.

FISCAL IMPACT:

Depending on the federal account under which the appropriation is made, match funds may be required. Federal match requirements are typically 80/20, meaning the CCSD would be responsible for 20% of the project cost and federal funds would cover the remaining 80%. However, some federal accounts, such as the Bureau of Reclamation, require 50% fund match.

DISCUSSION:

Congress recently approved the American Rescue Plan which includes Community Project Funding, a supplement to the traditional federal appropriations process that allows for direct project inclusion in federal appropriations bills. Each member of Congress is eligible to submit ten projects from their jurisdictions for consideration. Congressman Salud Carbajal's office has solicited the CCSD for projects to be considered for Community Project Funding. The project proposal deadline is Friday, April 16, 2021.

Congressman Carbajal's office has provided a link to an online form where project proposals may be submitted. The request is not a formal grant application. Agencies with projects selected for funding will be invited to complete a grant application with the applicable federal department through which funds have been earmarked. Should a CCSD project be selected for funding, the grant application would be made in accordance with CCSD policy, including review and approval by the Board.

Staff has prepared the attached list of projects for consideration.
