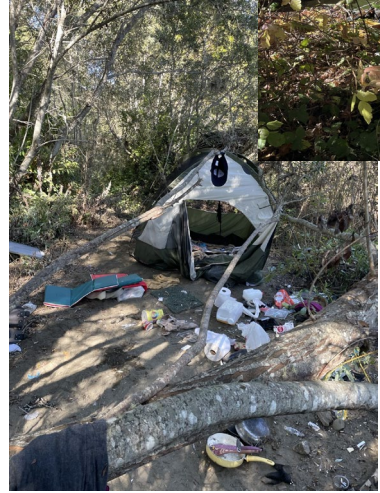

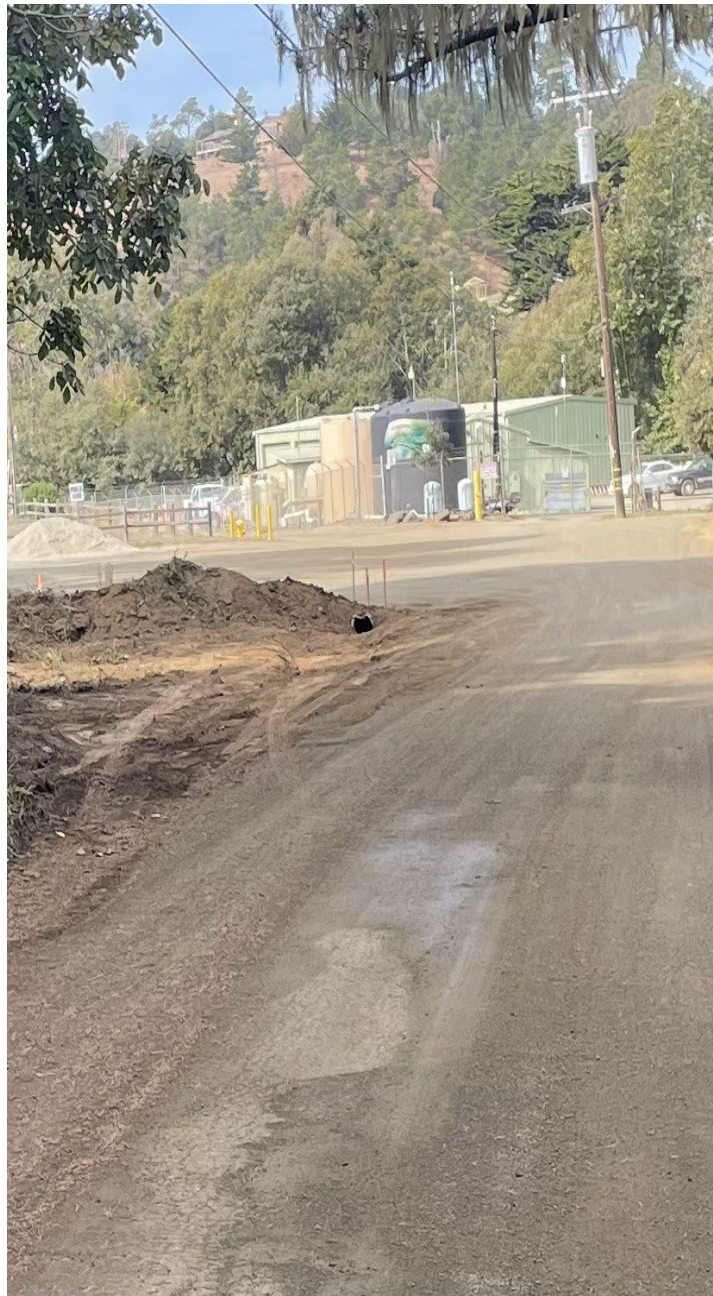


# Fiscalini Ranch Boardwalk

RIDGE TRAIL WOULD BE 6' X 40'

NO ACCESS IN WET WEATHER FOR VEHICLES.

ATV ACCESS ONLY DURING WET SEASON.

WORK WILL BE COMPLETED BY FFRP TRAIL VOLUNTEER GROUP AND F&R CREW WITH EQUIPMENT.

MATERIALS WILL BE PAID WITH DONATIONS AND VERY LITTLE COST TO BOTH PARTIES INVOLVED.
