A public hearing will be held by the Board of Directors of the Cambria Community Services District (CCSD) on March 16, 2023 at 1:00 p.m. at the Veterans Memorial Building, 1000 Main Street, Cambria, CA, and via Zoom Webinar to consider adoption of Ordinance 01-2023. This Ordinance will amend Chapter 6.04 of the Cambrian Community Services District Municipal Code and adopt the 2022 Edition of the California Fire Code and the 2021 International Wildland Urban Interface Code.
