

My experience, education and training, as follows, make me uniquely qualified to serve on the Cambria Community Services District Board of Directors:

- B.A. (History and Political Science); M.A. (History); J.D.
- Thirty-eight year career as an attorney specializing in land use, water and environmental law.
- Chief of Staff for a Member of the Orange County Board of Supervisors.
- Chief of Staff for a Member of the U.S. House of Representatives.
- Two full terms on the Cambria Community Services District Board of Directors from 2002-2010 (3 years as President and 3 years as Vice-President of the Board).

The focus of my efforts while serving on the Cambria Community Services District Board of Directors was on increasing the District's water storage capacity and advancing plans for a supplemental water supply. During my tenure on the Board of Directors, the Pine Knolls water tank facility was planned, engineered and constructed (doubling the water storage capacity of the District) and preliminary engineering undertaken to identify the optimum technology and location for a supplemental water supply. Through my liaison efforts with the U.S. Army Corps of Engineers, nearly the entire cost of the supplemental water supply investigation was borne by the federal government. The resulting CDM Smith analysis identified the brackish water treatment project that evolved into the supplemental water supply project authorized by your Board of Directors and constructed by the District.

A significant portion of my law practice involves California Environmental Quality Act and California Coastal Act matters under the jurisdiction of the California Coastal Commission. Should I be selected to serve on the Cambria Community Services District Board of Directors, my expertise in these areas and the relationships I have developed will bring added value to the District as the permanent Coastal Development Permit for the supplemental water supply project is pursued.
