Good afternoon, CCSD Board of Directors!

I write to draw your attention to page 254 of today's agenda, under Agenda Item 8D--Utilities Report.

Please see, if you haven't already, the most recent well-level readings posted on CCSD's website, August 16, 2021, as well as the table attached below indicating Stages of Drought in correlation to well-levels and gradient levels. https://www.cambriacsd.org/files/dd6e3516b/2021+Well+Reads.pdf

The table shown on page 254 of the agenda, implies that the August 2, SS well-level average reads indicate a **Drought Stage 3**, **which is 16.1 to 18.1 feet.** Since the actual well-level reads on August 2 indicated it was **12.53 feet**, I'm not understanding how the Drought Stage 3 calculation was arrived at in this agenda?

The **gradient** on August 2 was **1.46** -- SS4 to 9P2. According to the table, Mr. Dienzo presented to the Board, July 15, the gradient levels in a Drought Stage 5 are between **1.9--2.1**. (See table below for gradient levels/Stages of Drought)

The SS average well-levels reads from Aug 16, 2021, is 11.72 feet, indicating

a Level 6 Stage of Drought.

The gradient on August 16 was 1.36 -- SS4 to 9P2. The gradient level is shown to be at 1.8 in a Drought Stage 6. The table does not have a gradient equivalent below 1.8--we are clearly below that number!

It is incumbent upon the Board to take a serious look at the numbers presented here, and make decisions based on what is actual, as this town (as well as the state) is going through another significant drought. I find it sobering that it appears necessary to take my time to address what has not been presented to you in this agenda packet.

We have a facility that was built to address issues of extreme drought, which we are now experiencing; the District's numbers prove it! It's time to act in the best interests of our community and for the health and safety of us all.

These are the comments I intend to give at this afternoon's meeting. Please include them in the written record. Thank you.

Item 7B comment: Thank you for bringing this change to district procedures. These permit applications add new water users to a system that is already damaging the creeks and riparian habitat due to current extractions They need to be publicly vetted before they are approved, especially now that Cambria is coming to grips with 21st century water use. The Coastal Commission may be cheered by the appearance of the district taking steps to, if not stop approving permits that add new water users, at least making the process more public, and thus accountable. The inclusion of fire considerations is also significant. Cambria's narrow, winding streets make evacuation in the event of fire slow and dangerous. Adding more residents places more demand on streets that were not built to serve that level of population. I encourage the board to adopt this ordinance amendment, and then abide by it.

Item 7C comment: I welcome this change to the automatic approval previously given to these permit applications. While the district claims not to have land use authority to issue permits, which is technically the county's authority, the board and staff are well aware that the county views its role as a Pass Through agency, a rubber stamp, on any permit application which comes to it with district approval. This process has frustrated the Coastal Commissioners, who described it as, you will pardon me, but quoting, "Bullshit," and "If there was a lawsuit to bring against anybody, to me, it would be this CCSD," no kidding, watch the video of the November 6, 2020 meeting, and have suggested that they might need to put up a billboard in Cambria to tell the public, "Don't believe these people." That's you. So thank you for dodging further embarrassment by giving yourselves a law to obey. Two more permits, Bookout and Hadian, approved by district staff and the county, are now on appeal, which will be heard September 14. I encourage the board to add these two to the short list of ITS letters being suspended, and support the appeals. The Coastal Commission has told the applicants, the county and the district that these permits will be denied. Why give the Coastal Commission another occasion to humiliate the district? Stop these permits now.

Item 7D comment: Thank you for undertaking this Instream Flow study. Specifically, it addresses one of the requirements in the county's Information Hold on the district's application for a Coastal Development Permit for the EWS/SWF/WRF. The study was supposed to happen in Summer 2020, but 2022 is close enough. The Instream Flow Study is only one item. In more than a year since the CDP application was filed, the district has been unable to provide a single document to fulfill those nine pages of requirements, such as concurrence letters from various resource agencies, including California Fish and Wildlife, U.S. Fish and Wildlife Service, and State Water Resource Control Board regarding the proposed Adaptive Management Plan. The district has a biologist surveying the area, but no reports to the public or submitted to the county yet. Please make those reports public, and invite the biologist to report publicly. Utilities Manager Dienzo has told the board that he has documents to respond to the Information Hold. Please share these with the public, and provide a response as to why a year has passed without action. Water project critics are often blamed for the failure of this project to have a permit after seven years. The district's inability to complete the permit application is the reason, not public critics.

Item 8B Comment: Please thank Utilities Manager Dienzo for focusing on commercial

accounts for water conservation. that makes sense all year, regardless of Water Emergency status. With the Stage 4 Water Emergency, another area of conservation would be replacing the public restrooms with portapotties. It does not make sense to use scarce water to flush waste. And providing local businesses with rate relief in consideration of their allowing visitors to use their restrooms is indefensible during a Water Emergency. Don't do it. Conserve water so that we will all have adequate water. Note also the Will Serves listed. Has staff already approved these? Has the impact on water use been evaluated? Those are important questions to consider as all of us are conserving water in an uncertain future.
