Docent Walks

Brian Morgan led two walks in December and we have another four planned for January, largely focused on winter on the Ranch.

Ranch

Invasive species: West Coast Tree Service hauled away the ice plant that had been pulled by volunteers from Santa Cruz and the Sierra Club.

Trails: Before the December rains, volunteers added erosion control features, improved existing features, and graded several major trails to make them safer for visitors and locals. Foraging: Members of the public have been illegally foraging on the Ranch. My next CambriaCA piece will address this issue. The Management Plan specifically forbids foraging on the Ranch in any form.

2021

2021 was a very productive year for FFRP, with more ice plant removed than ever, many acres of forest treated for disease and storm recovery, and educational programs returning. Volunteers put in 3,050 hours between January and November (2,000 directly on the Ranch). I

2. FACILITIES AND RESOURCES SUPERVISOR The Facilities and Resource Supervisors , Carlos Mendoza's report was as

follows:

- * The recent rains brought some trees down on the Ranch on the forest loop trail and Santa Rosa Trail. However, no trails were closed for long periods during the clean up.
- * Part of the beloved Cambria sign on the East Ranch was damaged during the last rains and the Chamber has hired a contractor to repair it. He is waiting for the site to dry out so that he can drive his truck on it. The sign will then be repaired.
- * There was some damage to trees on the CCSD lots. An 8 inch tree fell on the side of a house damaging a gutter. The gutter has been repaired. Three trees have been flagged behind a house on Romney. They are waiting for approval from the County to be able to remove them. The Fire Department called in about some trees ready to fall on their station. Since a storm was on its way the trees were removed that day.
- * Several projects were accomplished during the past several weeks eg. upper cabinets at Facilities and Resources headquarters were finished, furniture bought for office, water heater replaced.
- * The water department moved a damaged water line on the East ranch. The line was put on the side of the bridge that connects Main Street and the East Ranch. The bridge is now reopened and is in very good shape after the contractor finished the work.
- * A street light, across from Red Wood Center was knocked down by a hit and run driver.
- * There is a wonderful piece in the Tribune on all the work that was done on the Ranch after last years storm.
