## 2. EX - OFFICIO REPORTS

A. Friends of the Fiscalini Ranch Report

Director Kitty Connolly reported as follows:

- 1) Wednesday weeding continues.
- 2) On July 16 volunteers will water the pine seedlings.
- 3) John Nixon has taken over publicity for Dogs on Leash. It is going well. There has been little conflict involved with the publicity so far. Commissioner Atencio did report a personal dog incident which involved his dog, another dog and a dog bite. He reported it was very alarming. The attacking dog was quarantined for 10 days.
- 4) The pine seedlings that are growing in containers will be transferred to the restoration nursery.

## B. Skate Cambria

#### 4. PRESENTATIONS

## A. Cambrians for Aquatics' Update

Before the presentation by Beth Yddovin, it was reported that we cannot as a Commission endorse anything. Endorsement is the job of CCSD. Her presentation was the same presentation as her presentation last month (see minutes for June). She requested that members of the Commission write letters in private support for the swimming pool at the High School. They will be presented to the school board on September 8th when Cambrians for Aquatics makes their presentation to the board. Beth reported that the superintendent of schools, Scott Smith, is very excited about the project.

## 5. FACILITIES AND RESOURCES MANAGER

Facilities and Resources Supervisor, Carlos Mendoza's report was as follows:

- A. It was reported by neighbors above the Berry Trail that someone had been driving up the trail and entering the street above. This is dangerous both to walkers and the driver of the vehicle. It is a trail and not meant to be driven on. Carlos and his crew put in a fence at the top of Piney Way. He is hoping this will solve the issue. They then did some work on the trailhead there.
- B. Weed Abatement is now finished on the fire breaks on the Fiscalini Ranch but is still going on in a few of the lots owned by CCSD. It definitely will be finished by the deadline of July 14th.
- C. Continuing the report from a month ago about the termites at Vet's Hall, two companies have given their report and bids to Carlos. There are definitely termites and the bids have been around \$35,000. It is hard to coordinate a date for the work because of the commitments of venues and also the American Legion's venues. Carlos is planning on getting the work done in two to three months. He will get the bids updated. The CCSD has approved the expenditure to do the work.
