1. OPENING

- A. CALL TO ORDER: Vice Chair Commissioner Atencio
- B. ESTABLISH QUORUM: Commissioner's Renshaw, Roche were present. Absent Commissioner's Kniffen and Johannsen. Alternates present Lord and Cooper
- C. CHAIR REPORT: None

2. EX - OFFICIO REPORTS:

- A. Jo Ellen Butler to Provide a Friends of the Fiscalini Ranch Report Here is her report:
- 1.In August Carlos and crew resurfaced the gravel portion of the Bluff Trail with FFRP volunteers rerouting traffic.
- 2. FFRP hired the three C's to remove dangerous trees and downed wood from Monarch overwintering areas.

They chipped the wood and piled it for the trails. Then on work day 8-18 20 people or so, with wheelbarrows, moved the chips to nearby trails to protect pine roots near the surface of the trails.

- 3. Trials committee met with Mike Anderson to talk about trails on the Ranch, design and permitting.
- 4. We held the first celebration of Spanish language tours on the Ranch on Sunday August 12 with between 40-50 in attendance,
- 5. FFRP had a table at Ocean Fair on August 25
- 6. Wednesday weeders meet tomorrow at Marlborough Entrance at 8:00 for removal of thistle and mustard.

- 7. Eucalyptus removal of 8"-18" DBA trees will be removed from near Huntington and chipped starting September 10. FFRP Has hired a crew to do the work. A biological survey will be performed this week to make sure no nesting birds or protected species will be disturbed.
- 8. Our next meeting is September 13 at Rabobank at 6:00PM.
- 9. FFRP will hold Coastal Cleanup Saturday 15 of September from 9-12. We will work the Coastal area of the Ranch and the Marine Terrace coast to Lampton. If we have enough volunteers we will do Santa Rosa Creek, but will not remove any homeless encampments.
