Ad Hoc committee members Scott and Harmon reported that they have not begun gathering information to write a needs assessment to forward to the Board regarding a Code of Ethics Policy. Committee member Townsend offered to provide information on the number of service districts that have an ethics policy and those which do not. Committee member Heinrichs suggested that we continue to work on the needs assessment and go further in depth to address the need for this policy. Committee member Scott thanked Committee member Heinrichs for forwarding two samples of ethics policies from other organizations to her.
